





## How to Fix a Trust Dilemma to Prevent a Tax Bomb

A bypass, or AB, trust splits into two trusts when one spouse in a married couple dies, cutting the estate taxes for beneficiaries.



Many clients and even other professionals are unaware that an irrevocable bypass trust, or funded B trusts, can be corrected to prevent higher ordinary income tax during the surviving spouse's lifetime and higher capital gains tax upon the surviving spouse's death. To understand the issue, a little history and background are needed.

First, every U.S. citizen is entitled to a lifetime credit against estate tax. This works like a very large standard deduction on an income tax return. Net estate values below this amount are not subject to estate tax.

The estate tax exemption is presently at \$13.61 million, or a combined \$27.22 million for a married couple. A net estate value in excess of that exemption is subject to a 40% tax. Not too terribly long ago (in estate planning terms), this exemption was only \$500,000. Net estates with value in excess of that amount were subject to a 60% tax. Almost everyone was worried about...

# In the News: John Saves Tax Client from Franchise Tax Board

John challenged the California Franchise Tax Board for a client and prevailed!



Our Client received \$2.9 million two weeks after changing his state of residency from California to Colorado. These funds were deferred compensation and retirement payments related to many years of services as a highly compensated employee for a national company while a California resident.

The California Franchise Tax Board asserted that the funds were related to the services performed as an employee as a California resident and taxable to California. After an 18 month battle, The Goralka Law Firm was able to establish that Federal Law precluded California from taxing these funds because my client was now a Colorado resident. The California Franchise Tax Board withdrew its notice as a result of the appeal and protest. The tax, penalties and interest saved amounted to approximately \$1 million.

Barbecued Chicken Salad Sandwiches

Craving a lunch that's both flavorful and satisfying?
Look no further than these BBQ Chicken Salad Sandwiches. This recipe takes juicy, grilled chicken and combines it with a tangy barbecue sauce and creamy mayonnaise for a sandwich that's bursting with taste. It's perfect for picnics, potlucks, or a quick and easy weeknight meal.



Total Time: About 1 hour

Prep: 15 min. + marinatingCook / Grill: 15 min. + cooling

Servings: 8

#### **INGREDIENTS**

- 1-1/2 pounds boneless skinless chicken breasts
- 1/2 cup barbecue sauce
- 1 cup mayonnaise
- 1/2 cup finely chopped onion
- 1/2 cup chopped celery
- 1/4 teaspoon salt
- 1/4 teaspoon crushed red pepper flakes
- 8 kaiser rolls, split
- 8 tomato slices
- 8 lettuce leaves

#### **DIRECTIONS**

- 1. Place the chicken in a shallow baking dish; add barbecue sauce. Turn to coat; cover. Refrigerate overnight.
- 2. Grill chicken, covered, over medium-high heat until a thermometer reads 165°, 6-8 minutes on each side. Cool; cover and refrigerate chicken until chilled.

3. Chop chicken; place in a large bowl. Stir in the mayonnaise, onion, celery, salt and pepper flakes. Serve on rolls with tomato and lettuce.




