Now, back to the symposium. Courses include a wide variety of topics. While we learned about new tools and techniques, we reaffirmed most of the advance planning techniques or tools that we have used for years. Those tools include:

Upstream Basis Trusts are designed to hold high-value low-basis assets in trust in order to receive a step-up in income tax basis upon grandpa, grandma or another older relative's death. This avoids capital gain upon the sale of the asset after the death of the older relative. Prior to that death, the client retains dictatorial control over the assets within the protected trust. The appropriate use of the Upstream Basis Trust had provided transformative changes for many of our client families. For example, real estate investors can sell the real estate investments free of tax in order to cash out for retirement after decades of hard work managing real estate investments.



## Four Key Elements of a Good Estate Plan

An estate plan can be complex or simple, depending on your estate and your wishes, but every estate plan should accomplish these basic goals.



There are many types of estate plans, both complex and simple, revocable and irrevocable. However, all estate plans should accomplish four basic goals. First, if you are sick and unable to act, your estate plan should empower the

designated person to step in to help make decisions. At death, your estate plan should:

- Get your assets to the right people
- · Distribute your assets at the right times
- Deny access to the wrong people

Each of these goals is discussed separately below.

### A good estate plan empowers someone to act on your behalf.

If you are sick, your estate plan must empower your designated person to act on your behalf for financial matters. This person may act as the successor trustee or as the attorney-in-fact under a power of attorney. Most estate plans will require a letter from your doctor, or perhaps two doctors, confirming that they have examined you and that you are not able to handle your affairs.

# Business Owners: We Can Help You File Your Required Beneficial Ownership Information Report (BOIR) by John M. Goralka, Esq.

New Filing Requirement for Companies for the Corporate Transparency Act



Effective January 1, 2024, the Corporate Transparency Act (CTA) mandates that all domestic business entities (including corporations, LLCs, and LLPs) and foreign-registered businesses, unless exempt, must file a Beneficial Ownership Information Report (BOIR) with the Financial Crimes Enforcement Network (FinCEN), a bureau of the U.S. Department of the Treasury.

The CTA aims to combat money laundering, terrorism financing, and other illicit financial activities. Willful noncompliance can result in severe civil penalties of \$591 per day and criminal penalties of up to \$10,000 and two years of imprisonment.

We strongly encourage you to review the BOIR filing requirements and ensure timely compliance to avoid any penalties.



**RECIPE OF THE MONTH** 

Best Chicken Tortilla Soup

We've heard it time and time again – this is the **best chicken tortilla soup** you'll ever taste! With just a few simple tricks, you can elevate the flavors to new heights while keeping the prep time to a minimum.

Whether you choose to make it in your crockpot or on your stovetop, this recipe is a healthy and delicious Mexican delight that's sure to be a hit with everyone.

Perfect for any occasion, it's a true crowd-pleaser that will have your guests coming back for seconds.

Total Time: 4 HRS 20 MINS

Prep Time: 20 MINSCook Time: 4 HRS

Servings: 6 SERVINGS

### **INGREDIENTS**

- 3 dried Mexican peppers guajillo, pasilla, and ancho
- 1 tablespoon cooking oil, we like avocado oil
- 1 medium onion, chopped
- 3 cloves garlic, minced
- 1 teaspoon ground cumin
- 8 skinless bone-in chicken thighs
- 8 cups chicken stock
- 1 tablespoon sea salt
- 15 ounce can diced tomatoes
- 15 ounce can black beans, drained and rinsed
- 2 cups frozen corn
- Optional toppings: sour cream, queso, limes, cilantro

### The Crispy Tortillas

- 1 teaspoon cooking oil
- 4 large tortillas cut into thin strips, use gluten-free, if needed

#### **DIRECTIONS**



- 1. Place the dried peppers in a bowl and cover them with about a cup of hot tap water.
- 2. Heat the tablespoon of oil in a large frying pan over medium-high heat. Add the onion and cook until it is well browned, about 7-8 minutes. Add the garlic and cumin and cook for 1 minute more.
- 3. Pull the stems off of the peppers. Add the peppers and the soaking water into your blender. Add the cooked onion and blend until smooth. If it is too thick to blend properly, add some of the stock. Pour this liquid into your crockpot or a large soup pot.
- 4. Add the chicken thighs, chicken stock, sea salt, and tomatoes. Set the crockpot to high for 4 hours or low for 8 hours. If cooking in a pot, you want the pot to simmer very gently.
- 5. Remove the chicken from the crockpot or pot. Separate the meat from the bones and discard the bones and shred the meat. Return the meat to the pot and add the black beans and corn and let them heat through.
- 6. Serve the chicken tortilla soup with the tortillas on top and any or all of the optional toppings.

### The Crispy Tortillas

- 1. Preheat your oven to 350 degrees.
- 2. Put the tortilla strips on a baking sheet and toss them with the oil. Spread them out on the baking sheet then put them in your oven. Let them toast for about 10-15 minutes, gently mixing them up twice until they are lightly browned. Remove them from the oven. Note: they will continue to crisp as they cool.

### **NOTES**

We've tried many different combinations of peppers and every time this soup turns out great. The important part seems to be that you use dried peppers, not necessarily which types of peppers you use. If you would like a spicier soup, add one spicy chili pepper, like chili de arbol, into the mix.

Make sure you use bone-in chicken. The bones are what make the soup extra flavorful. Usually, bone-in chicken is sold with the skin on, simply pull the skin off before putting the chicken in the pot.
