

### You've Got a Trust: Now Who Should Be the Successor Trustee?

You've set up a trust to protect your assets and your beneficiaries, but you still must choose the right person to execute your wishes. Here's how to do that.



A trust is a powerful estate planning tool, providing for the management and protection of your assets. Trusts come in many flavors or types depending upon the client's goals and needs. The selection of your trustee or successor trustee will depend upon the type of trust and your goals and objectives.

#### Irrevocable trusts

Irrevocable trusts are generally used to attain certain income tax, estate tax or asset protection objectives. These trusts may use both an investment trustee to oversee trust investments and an administrative or distribution trustee to supervise other managed duties. This structure allows a client to retain control over trust assets, investment activities and accounts, while still benefiting from the desired asset protection or tax benefits, which typically would prevent you from being trustee.

#### Revocable trusts

This article focuses on the selection of the successor or trustee for revocable or living trusts. The successor trustee of your living or revocable trust steps in to act if you are no longer able to do so due to your death or mental incapacity...

### 1. None of us has a specific expiration date.

## Case Studies: Saving Our Clients Millions of Dollars

Saved \$88 Million Client Millions in Taxes and Created Income for Life

For our client with an \$88 million estate holding substantial income producing real property, we were able to provide a plan to transfer real property worth over \$50 million out of his estate for estate tax purposes. In addition, only 3% of the value of the real estate was reassessed for property tax purposes, and the client receives approximately 84% of the net income from the property for life. The client retained control over the \$50 million in property interests through control of the business entity and the Trust holding the property interests.

The California Franchise Tax Board asserted those funds were taxable, even after our client moved from California to Colorado. After an 18 month battle, The Goralka Law Firm was able to establish that Federal Law precluded California from taxing these funds because my client was now a Colorado resident. The California Franchise Tax Board withdrew its notice as a result of the appeal and protest.

# RECIPE OF THE MONTH Slow Cooker Beef Stroganoff

Beef stroganoff was one of my favorite meals that my mom made. Although I don't have her exact recipe, she always included a can of Campbell's Cream of Mushroom Soup.

This recipe tastes just like my mom's, especially when you add a can of cream of mushroom soup.

**Total Time:** 4 hours and 15 minutes

Prep Time: 15 minutesCook Time: 4 hours

Servings: 8



#### **INGREDIENTS**

- 2 ½ pounds stew meat, cut into 1-inch cubes
- 1 teaspoon garlic salt
- ½ teaspoon black pepper
- ¼ cup flour
- 3-6 tablespoons olive oil
- 3 tablespoons cold butter, separated
- ½ cup white wine
- 16 oz. button mushrooms
- 1 small yellow onion, diced

- · 4 cloves garlic, minced
- 4 cups beef broth
- 1 tsp better than bouillon, or 1 beef bouillon cube
- 2 tablespoons red wine vinegar
- 2 tablespoons Worcestershire sauce
- 2 tablespoons Dijon mustard

#### To thicken:

- ¼ cup cornstarch + ¼ cup cold water
- 1 ½ cups sour cream, not reduced fat
- 10.5 oz. cream of mushroom soup

### For serving:

• 1 pound wide homestyle egg noodles

### **INSTRUCTIONS**

- 1. Cut the beef into one-inch cubes and pat completely dry. Discard any large pieces of fat. Fat that's marbleized into the meat is fine.
- 2. Season with garlic salt and pepper. Sprinkle with flour and toss to coat.
- 3. Heat 2 tablespoons olive oil in a skillet over medium-high heat. Sear the meat in batches for 45 seconds per side, until browned but not cooked through. Use kitchen tongs to carefully remove and set aside on a plate. Add more olive oil between batches as needed and decrease heat slightly if the pan gets too hot.
- 4. Add 1 tablespoon butter and white wine to the pot over medium heat. Use a silicone spatula to "clean" (deglaze) the bottom of the pan. Add the onions and mushrooms and cook for 4 minutes. Add the minced garlic and cook for 1 more minute. Remove from heat.
- 5. Add the beef broth, bouillon, red wine vinegar, Worcestershire sauce, and Dijon mustard to the slow cooker and stir to combine. Add the beef as well as any juice that may have dripped onto the plate. Add the onions/mushrooms/garlic.
- 6. Cook on high for 4-5 or on low for 8-9 hours.
- 7. Combine the cornstarch/cold water mixture and whisk it into the slow cooker.
- 8. Flip to warm.
- 9. In a medium bowl, whisk sour cream with 1 cup liquid from the slow cooker until smooth. Add to slow cooker and stir carefully to combine.
- 10. Stir in the condensed cream of mushroom soup.

- 11. Finally, turn heat off and swirl in 2 tablespoons of cold butter. This adds a smooth, velvety finish.
- 12. Serve over egg noodles. If desired, add cooked/drained egg noodles right to the slow cooker, stir to combine, and serve!

#### Notes:

Storage: store in an airtight container and refrigerate for up to 3 days or freeze for up to 3 months. I recommend that you freeze the sauce on its own and boil fresh noodles when you're ready to serve it again.
